# Medicare Transition of Care

#### What is Medicare Transition of Care?

Medicare Transition of Care (MTOC) conveniently enables you to complete a dental service that you started with your dentist, even if that dentist is not in the LIBERTY network.

Services that qualify are those that typically require more than one trip to a dental office for completion. To qualify for this coverage, you will need to have started a dental procedure in 2023 that is expected to be completed in 2024. You maybe able to continue this treatment until **March 31, 2024.** 

You can continue the procedure with your dentist at LIBERTY in-network coverage levels.

# Examples of dental conditions that may qualify include, but are not limited to:

- Re-treatment of Root Canal
- Full/partial dentures
- Crowns/bridgework
- Bridges

# Examples of conditions that do not qualify include, but are not limited to:

- Cleanings/exams
- Periodontal Services
- Fillings



#### How do I get coverage?

There is no need to enroll in MTOC. If you are currently undergoing dental treatment by a carrier outside of the LIBERTY network, you will be able to finish that treatment as long as it is covered under the MTOC eligible benefits.

### Transition of care coverage is only possible if:

- Your provider agrees to continue your treatment
- The service is a covered benefit by your plan
- The service is eligible for MTOC

**Note**: Dental services that have not yet started will not be covered under the transition of care coverage.

#### How long does MTOC coverage last?

You may be able to continue your coverage up to **March 31, 2024**, but this may vary based on your condition.

## Can I receive in-network coverage for a non-related service?

In-network coverage levels that are part of MTOC only apply to the approved dental services. They cannot be applied to another dental service.
